Dear Governor Brown –


Enclosed is a copy of the letter of September 7, 2017 which by now has been hand-delivered, as individually addressed, to the office of each Senator. The letter of the 7<sup>th</sup> encloses letters of July 19, August 10, and August 24, each dealing with differing areas of scientific and legal concern about SB 649. The July 19 letter is a compact treatment of the law and science issues in SB 649.

The FCC standards for safety certification of cellular devices, which standards are now three years overdue from previously announced revision, are entirely based on the theory that it is only when the heat-from-microwave has reached a threshold sufficient to cook tissue that there is a danger to the recipient of such microwave. ***Missed all along is the direct catastrophic effect of the microwave-caused vibration itself on DNA, see the July 19 letter.*** Sources in the July 19 letter show that the mechanism of actual DNA fracture is acoustic, in the physics use of the term. There is an interesting and fun YouTube illustration of the general concept of acoustic fracture to be found by searching for “1972 Ella Fitzgerald Memorex.” Microwave vibration causes DNA strand fracture, leading to mutagenic process, and also leading to many other health harms, some immediate. For human health Senate Bill is the most significant legislation ever pitched.

This letter has two core purposes: First to respectfully assure that your office has the enclosed letters. Secondly, with motives which are a mixture of advocacy and personal interest, I request a meeting with you, allowing such time as you may be able to spare for myself and, if desired and possible, an accompanying scientist, regarding SB 649.

As to my purely personal reasons for seeking a meeting, thank you for signing George’s SB 95, which was the last time, so very long ago, that I was in Sacramento with devotion to the outcome of a Bill. Those were the days of essentially nonpartisan giants like Peter Behr, whose office was supportive of our successful efforts to get SB 95 through the Legislature. SB 95 had been suddenly doomed to failure in the Senate when the colorful Omar Rains announced that he was leaving due to illness. A conversation with that office brought him back to the Senate floor, and SB 95 passed by that one vote, after which I left politics, feeling that great suffering had been abated, and that karma was balanced from the days when the late great Lyn Nofziger used to horribly pun ‘better a Harry Lehmann than a bald priest.’ Vast health risks will be avoided through the defeat of SB 649, and at the very least further study is required. I hope you will be so kind as to grant me a brief meeting, but regardless of your choice in that regard I thank you for your many decades of sincere service, and know that you will find the enclosed letters good sources of data. I note in closing this letter that I argued before our Supreme Court in 1978, Chief Justice Bird was angelic, and what happened in 1986 was a sin against the rule of law.
